Purpose and Goals – Facilitated by Darlene Ward

The purpose of roundtable is to gather guidance and recommendations for the annual report that are grounded in the realities of the child welfare workforce.

OCFS Workgroup Update - OCFS Staff

• OCFS reconvened a workgroup to focus on workforce issues such as availability and accessibility of the civil service exam, accurate and useful trainings, and uplifting the public image of child welfare workers.

Child Welfare Workforce Wellness – Facilitated by Ariela Perez-Wallach

• Ideas to improve wellness included higher salaries, lower caseloads, peer support/cohorts for new staff, and combatting inaccurate assumptions associated with being a child welfare worker. Addressing safety issues in the workplace and doing an ACE's assessments for employees were also suggested.

Child Welfare Workforce Retention – Facilitated by Darlene Ward

 Ideas to improve retention included increased mentorships and supervision, providing support to workers when a crisis happens and combatting public perception of child welfare workers. Research has shown that if a child welfare worker stays on the job for 2 years, they are much more likely to stay in the field, which means children will be discharged from the system more quickly.

Child Welfare Workforce Recruitment – Facilitated by Ariela Perez-Wallach

• Suggested recruitment strategies included paying off student loans for employees, supporting students of color who plan to enter the field, and eliminating barriers to entry level jobs.

Fiscal Considerations – Facilitated by Darlene Ward

 There may be fiscal opportunities with Medicaid funding. It was also recommended that NYS expand the use of Title IV-E dollars to be used to help employees pay for student loans and also attract new students with scholarships.

Focusing Recommendations – Facilitated by Ariela Perez-Wallach

 Emerging themes include the reinstated of Title IV-E money, the importance of mentorships and supervisory trainings, funding agencies for extra case workers to address the turnover rate, and the potential impact for children and families in NYS if more funding and resources is not invested in the child welfare workforce.
